Decisions of the Council

The ISU Council met on June 8 and June 15-16, 2024 in Las Vegas, USA. The following were among the decisions taken by the Council during the meeting.

1. New Full ISU Members

The ISU Council granted full ISU Membership with immediate effect for the following:

- Ecuadorian Skating Federation, for the Figure Skating Branch
- Portuguese Winter Sports Federation, for the Speed Skating Branch

2. ISU Communications with continued validity

The Council acknowledged the unanimous Congress confirmation of the [ISU Communications having continued validity](#). As also indicated in ISU Communication No. 2629 (2024 Congress Agenda), Communications informing about Decisions of the ISU Disciplinary Commission and/or the Court of Arbitration of Sport (CAS), are not listed but remain valid. The Communications "Decisions of the Council" including periodic decisions such as allotments of ISU Events, Membership issues, Appointments, World Record homologations and other information/statistics are not listed but remain valid.

3. Definite allotment of ISU Championships season 2024/25

In accordance with Rule 127 of the ISU General Regulations, the Council has definitely allotted the Championships for 2025 as follows:

4. Provisional Allotment of ISU Championships season 2025/26

In accordance with Rule 127 of the ISU Regulations, the Council has provisionally allotted the following 2024 Championships:

ISU World Junior Synchronized Skating Championships 2026 to be held in Gdansk, POL, on March 13-14, 2026

5. Provisional Allotment of ISU Championships season 2026/27

The Council decided to postpone the allotment of the pending 2027 ISU Championships until its meeting in September 2024. In this regard, ISU Members are invited to make applications for the following Championships by **September 2, 2024**:

6. Provisional Allotment of ISU Championships season 2027/28

The Council decided to postpone the allotment of ISU Championships season 2027/28. Further details will follow in due course.

7. Change of Venue Junior Grand Prix Figure Skating Season 2024/25 – Türkiye

The Council approved the request to change the venue of the Junior Grand Prix September 18-21, 2024, to Ankara, Türkiye (instead of Istanbul).

8. World Cup Speed Skating Season 2024/25

The Council confirmed the venue of the World Cup Speed Skating on January 31-February 2, 2025 as Milwaukee, USA.

9. World Cup Short Track Season 2024/25

The Council confirmed the venue of the World Cup Short Track on February 7-9, 2025 as Tilburg, NED.

10. Junior World Cup Short Track Season 2024/25

The Council confirmed the Junior World Cup Short Track Season 2024/25 as follows:
